Cabinet Office publishes updated plan to cut red tape

The Cabinet Office has published its updated Simplification Plan, <http://bit.ly/caboffsim> or www.cabinetoffice.gov.uk. A key part of this plan is the Office of the Third Sector (OTS)' work to cut red tape for third sector organisations. This includes commissioning and funding practices and using regulation to empower third sector organisations. The Government welcomes ideas that will cut red tape and they can be submitted via the Better Regulation Executive website, www.betterregulation.gov.uk.

Comprehensive Area Assessment (CAA) reports on life in local areas

Oneplace, an interactive website providing information on the outcome of CAA in all top tier local authority areas, was launched on 9 December. CAA is the new way of measuring the performance of councils and other local public bodies, such as the police and fire service, in every area.
